- 161,481 visits (117,944 in 2024) (+37%)
- 128,194 visitors (87,670 in 2024) (+46%)
- RSGB continue to introduce a series of new initiatives to attract traffic to the site
- The newsfeed has 2,570 subscribers
- 26 RSGB news items published
- 4 items relating to the Academy & regular course email cascades
- Media contact on a range of subjects such as, electric bikes, eye tests, drink drive limit, etc.
- X 21,700 followers (a slight drop against 2024 which was expected with change of ownership)
